


Municipality of Ampelokipi - Menemeni

Greece



The Municipality of Ampelokipi – Menemeni, with head offices in Ampelokipi, was the result of the merging of the Municipalities of a. Ampelokipi, established under the Royal Decree of 06/10/1954 (GG 264A/19-10-1954), and b. Menemeni, established under the Presidential Decree 554/1982 (GG 98 A/23-8-1982), according to article 1 of L.3852/4.6.2010 (GG 87A/7-6-2010) "New Architecture for the Local Government and Decentralised Administration – Kallikratis Program". Under those provisions, our Municipality consists of two Municipal Communities, the Municipal Community of Ampelokipi and the Municipal Community of Menemeni.

Geographically, it belongs to the Prefecture of Thessaloniki and occupies the north-western side of the Thessaloniki Conurbation, bordering with the Municipalities of Delta (West), Kordelio – Evosmos (Northwest), Pavlos Melas (North), Neapoli – Sykies (East), Thessaloniki (Southeast) and washed by the Thermaic Gulf in the south.



Its total area is 9,792sqm and morphologically it is classified as lowland.

Due to the passing of the main arteries and rail corridors through the city of Thessaloniki, the area covered by the municipal community of Menemeni features limited residential development, and, compared to other western Municipalities, it is slightly urbanized. This urbanized area is connected to the municipal community of Ambelokipi, which is fully developed residentially.

The population, according to the 2011 census is 52,127 residents. However, according to estimates of local officials and Municipality representatives, it is estimated that the new Municipality has approximately 90,000 residents.

Employment:

Locals are employed mainly in the secondary and tertiary sector.

The municipal community of Menemeni hosts large industrial and trades facilities, wholesale businesses and service stations. The area also hosts oil facilities, the cement facilities of "Heracles", the EKO facilities, the KTEL (Joint Bus Receipts Fund, intercity bus services) facilities, the central Vegetable Market and Meat Market of Thessaloniki, the

Vehicle Inspection Centre (KTEO), the Directorate of Transport and Communication, Thessaloniki, and many transportation companies.

The municipal community of Ampelokipi is largely commercial, with many carriers and numerous entertainment options. Its secondary sector accommodates various non-intrusive manufacturing activities.

The Municipality of Ampelokipi – Menemeni is a modern and dynamic city providing almost all services both to its residents and visitors.

Culture:

For the implementation of its cultural program and the provision of quality cultural stimuli, the Municipality provides with the following:

- Municipal Conservatory
- Cinema theatre "ALEXIS MINOTIS"
- Cultural Center Karapantseio, theater and cinema room "Sofia Vempo"
- Cinema theatre "Astron"
- Cultural centre of Menemeni, where there is a division of the Municipal
 Conservatory. Also, traditional dance and choir classes are available.
- Area of cultural activities in the building located at 26 Octombriou Str in Ampelokipi, where painting, dance and ballet classes are available.



- Two municipal libraries for adult use and three municipal libraries for minors use

- Theatre adult and children group, performing within the Municipality premises and outside





Cultural events:

The Municipality hosts annually a multitude of cultural events, such as:

- The "Ampelokipeia"
- The "Chalkideia"
- Flower Exposition
- The "Kladaries" traditional custom revival
- "In the neighbourhoods of our Municipality" music events
- Carnival and Christmas events
- Celebrations of anniversaries and international days

- Music nights and concerts
- Theatre performances, film shows etc.

Historical Sites, monuments:

- The Indian cemetery lies within the boundaries of the Municipal Community of Menemeni. The cemetery served for the burial and cremation of the Indians called up by the British to boost the Allies' army during WW I. The northern side of the cemetery has an octagonal monument of 220 Hindus that were cremated, while the southern side has 105 tombs with vertical stone plaques.
- The Allied Forces cemeteries "Zeitenlick" is located within the boundaries of the Municipal Community of Ampelokipi, which hosts the tombs of the victims of the Allies of Greece during WW I. It is the resting place of 8,000 Serbs (of whom 129 were victims of World War II), 8,089 French, 400 Russians, 1,648 Englishmen and 3,000 Italians.

Sports:

In order to meet the sporting needs of citizens and clubs there are various outdoor and indoor sporting areas, as well as open spaces for *freeform* exercise:

- municipal stadium "Konstantinos Karamanlis" (football field, eight-lane track)
- two football fields (covered with plastic turf 11X11)
- two 5X5 fields
- three tennis courts
- indoor track field "Anastasia Kelesidou"
- ten indoor gyms for various sports
- one inter-municipal indoor gym
- ten basketball courts for public use
- two courts 5X5 for public use
- one volleyball court for public use







The Municipality implements various sports programs for children, adults, seniors, exercise for the Roma, as well as special programs for people with chronic diseases and kinetic / mental disabilities. Furthermore, seasonal programs for winter and summer activities (child and the sea, hiking, etc) are organized, as well as various sport events, such as:

- Two-day 3X3 basketball game
- Mountain bike races public cycling races
- Events for the programs "SPORTS FOR ALL"
- The international marathon "MEGAS ALEXANDROS" (ALEXANDER THE GREAT) of 10 and 5 km runs
- Award ceremonies of distinguished athletes

- Intermunicipality cooperations (bike-rides, run for the military camps, etc)

Moreover, more than 29 sport associations for a variety of sports operate in the municipality, having a rich action range and successes.

Social Policy:

The Municipality provides welfare services to its citizens; specifically, it provides with:

- seven municipal playschools
- four nursery school stations
- one nursery
- three centers for children's creative activities (K.D.A.P.)
- centre for disabled children's creative activities (K.D.A.P. ME.A)
- four centers for the open care of the elderly (K.A.P.I.)
- day-care centre for the elderly (K.I.F.I.)
- three social programs "Help at Home"
- youth information centre
- community centre with a Roma division
- social grocery
- social pharmacy

As regards health, there are:

- one municipal group practice in Ampelokipi, providing primary healthcare to citizens with various medical specialties (with a division in the municipal community of Menemeni in the area of Aghios Nektarios, ex Dendropotamos).
 - one microbiology laboratory, for the members of the K.A.P.I (the elderly) and the rest of the citizens of the municipality
 - 3 physiotherapy departments
 - Municipal blood bank that organizes voluntary blood donations of KEP health
 - KEP health

The social service of the municipality provides supportive psychosocial services with

personal and family counseling, as well as information on social welfare issues. Moreover, a clothing bank operates under its supervision, where clothing, shoes and toys are offered at no cost to the bank and then donated to socially vulnerable citizens.

Finally, as regards employment, the Municipality runs the following:

- information office for the unemployed and the companies, which guides and assists unemployed citizens, aiming at forwarding them in employment
- Youth entrepreneurship counters

Education

In respect of a long-term strategic planning in operation, the Municipality has managed to upgrade education, troubleshooting school accommodation and succeeding in the single zone operation of all schools.

The Municipality runs:

- twenty kindergartens (conventional and all-day kindergartens)
- fifteen primary schools
- six junior high schools
- one arts junior high school
- one evening junior high school
- five senior high schools
- one night senior high school
- arts senior high school classes
- Technical Vocational School Professional School (T.E.E. EPAL)
- Second chance school

Furthermore, various adult and student training programs are organized, promoting lifelong learning, environmental conscience and aiming at the improvement of parent-children relations.

Partnerships:

✓ Greek Intermunicipal Healthy Cities Network (G.I.H.C.N.):

G.I.H.C.N. aims at preventing diseases, promoting health, health screening of high risk population groups and promoting integrated policies and actions, in general, in the field of Public Health. The Municipality of Ambelokipi – Menemeni is a member of G.I.H.C.N. since 2011.

✓ Cooperation with institutions and NGO

The Municipality in cooperation with various institutions (e.g. hospitals) and NGO implements communication actions to the public of a wide range of current affairs such as the diabetes mellitus, AIDS, vaccinations, learning disabilities etc. At the same time, communication actions assist in implementing regular health screenings.

- ✓ The Municipality participate in the "Covenant of Mayors" aiming at the optimal energy efficiency, the reduction of the pollutants emissions CO2 and the use of renewable energy sources at a 20% rate until 2020. An action plan for the energy efficiency is under construction for the planning of the aforementioned, which articulates the existent situation and the actions leading to the goal's accomplishment.
- ✓ The Municipality participates in the Green Greek Cities Network (G.G.C.N.)
 that aims to lead the sustainable growth and the improvement of the urban environment. Their ambitions are to produce proposals and applicable solutions in common problems of Greek cities such as the restricted public

- spaces, the pollution, waste management, environmental awareness etc.
- ✓ The Municipality upon the city council's resolution participates in the European Group of Territorial Cooperation H.E.L.I.C.A.S (E.G.T.C.) under the distinctive title HELICAS. When communicating with organizations out of Greece, the name of the E.G.T.C. will be attributed as "Holistic Efficient Local Initiatives for Cooperation and Synergy European grouping of territorial cooperation" and the distinctive title is "E.G.T.C. − H.E.L.I.C.A.S." whose main statutory objectives constitute the 11 thematic goals of the Strategic Europe 2020.
- ✓ The Municipality upon the city council's resolution participates in the
 European Group of Territorial Cooperation (E.G.T.C.) under the name
 "E.T.C.G. Efxini (Welcoming) City European Cities Network for Sustainable
 Growth" and under the distinctive name "E.G.T.C. SolidarCity NETWORK".

 The network was set up in 1995 under the name Greek Network of Local
 Governments for the Social, Cultural, Tourist, Environmental and Agricultural
 Growth.
- The Municipality is a member of the Thessaloniki Metropolitan Development Agency S.A. with a shareholding of 4,85% of the share capital as well as in the "Standing Committee for the Metropolitan Development Convergence" of the Thessaloniki Metropolitan Development Agency S.A. aiming at the strengthening of the inter-municipal cooperation on Metropolitan level, the coordination of the actions on inter-municipal planning issues and the fostering of partnerships among the municipal shareholders of the company.
- ✓ The Municipality supports the program, entitled : JustRom3 "Access of Roma women to justice", that is an initiative of the Europe Council and the European Commission. It aims at eliminating the multiple discriminations and at the improvement of the access of the Roma women to the justice system. The countries, apart from Greece, that participate are: Bulgaria, Italy and Romania.
- ✓ The Municipality cooperates with the prevention centre "Alpha Network".

This center is one of the 70 prevention centers that are currently operating in Greece and are recognized entities by the state. The main aim of their function is the prompt intervention, so as to reduce the chances of involvement of the youth in harmful to their health types of behavior, one of which is the use and addiction to psychotropic substances.

✓ The Municipality takes part in the European network **PAL NETWORK** which is working for the inclusion and support of the education and employment of the sensitive groups (Roma, Gypsies, Travellers).

- To empower the members of the PAL Network to work for the Integration of the Roma
- To promote, coordinate and contact pioneering research on the education and employment of the Roma
- To prepare and promote integration policies.
